

Confidentiality Agreement:

This Agreement is entered into this ____ day of month_____, year _____ by and between

(hereinafter "Recipient") and iBloom Technologies Pvt Ltd., with offices at 1st Floor, CIIE, IIM Ahmedabad, Vastrapur, Ahmedabad, 380015 (also hereinafter "Discloser").

WHEREAS Discloser possesses certain ideas and information relating to distribution of information and knowledge through the medium of documents on the internet and trade secrets and future plans of iBloom Technologies Pvt Ltd. and that is confidential and proprietary to Discloser (hereinafter "Confidential Information"); and

WHEREAS the Recipient is willing to receive disclosure of the Confidential Information pursuant to the terms of this Agreement for the purpose of evaluating future employment or potential of contract work only OR an investment opportunity OR both;

NOW THEREFORE, in consideration for the mutual undertakings of the Discloser and the Recipient under this Agreement, the parties agree as follows:

1. Disclosure. Discloser agrees to disclose what is deemed as "need to know" determined solely by the discloser. Receiver agrees to receive the Confidential Information.

2. Confidentiality.

2.1 No Use. Recipient agrees not to use the Confidential Information in any way, or to manufacture, develop, code or test any product or website embodying Confidential Information, except for the purpose set forth above. With this the Recipient also agrees to not be a founding member or a key personnel or seed investor in any legal entity based in India, US or any foreign country engaging in a similar business as the discloser. Also the Recipient agrees to not use this confidential information at any future employers unless the future employer has already been in business of distributing presentations and documents on internet prior to the date of this agreement.

2.2 No Disclosure. The recipient agrees to keep in strict confidence and will not, except as expressly authorized in writing by discloser, publish or disclose, either orally or in writing, during and after the period of consideration or work assignment, any confidential, private or proprietary information of Company or its suppliers or customers (including, but not limited to, specifications, requirements, drawings, sketches, models, designs, methodologies, processes, know-how, research and development, samples, tools, computer or other apparatus programs, software, source code, trade secrets, product plans, projects, inventions, engineering information, hardware configuration information, technical information or data, financial information, business plans, other business information or data, customer information and data, vendor information, market information, or marketing plans, whether written, oral or otherwise) which the recipient may in any way acquire, learn, develop or create by reason of such work or assignment or consideration (collectively, "Company Confidential Information"). The recipient will use Company Confidential Information only in connection with evaluating the potential for employment with the Company; As such the recipient will not use Company Confidential Information for any other purpose.

2.3 Protection of Secrecy. Recipient agrees to take all steps reasonably necessary to protect the secrecy of the Confidential Information, and to prevent the Confidential Information from falling into the public domain or into the possession of unauthorized persons.

3. No contract of Employment. This agreement does not imply any contract of employment between the discloser and recipient.

4. No contract of Ownership or Stake. This agreement does NOT imply any contract or commitment of investment by recipient or any commitment of stake in iBloom Technologies Pvt Ltd on behalf of the discloser.

5. Ownership of Confidential Information. Recipient agrees that all Confidential Information shall remain the property of Discloser, and that Discloser may use such Confidential Information for any purpose without obligation to Recipient. Nothing contained herein shall be construed as granting or implying any transfer of rights to Recipient in the Confidential Information, or any patents or other intellectual property protecting or relating to the Confidential Information.

6. Return of Information. Upon request by the discloser, the recipient will return to discloser all Company Confidential Information received in tangible form or destroy all such Company Confidential Information and certify in writing to such destruction.

7. Term and Termination. The obligations of this Agreement shall be continuing until the Confidential Information disclosed to Recipient is no longer confidential.

8. Survival of Rights and Obligations. This Agreement shall be binding upon, inure to the benefit of, and be enforceable by (a) Discloser, its successors, and assigns; and (b) Recipient, its successors and assigns.

9. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY THE LAWS OF THE STATE OF Andhra Pradesh, India. WE AGREE TO THE EXCLUSIVE JURISDICTION AND VENUE OF THE STATE OR COURTS LOCATED IN THE HYDERABAD AREA.

10. If any portion of this agreement is unenforceable, the remainder of the agreement will stay in effect.

11. The Recipient understands that the discloser has the right to receive an injunction from a court if the agreement is breached.
